MARKETS AND THE ECONOMY

The S&P 500 Index increased 2.3 percent in May, marking its seventh consecutive month of gains. The U.S. Commerce Department revised first quarter gross domestic product growth downward, from 2.5 percent to 2.4 percent. The Consumer Price Index decreased 0.1 percent in April but has increased by 1.1 percent over the last 12 months. New home sales in April increased 2.3 percent over March and are up 29 percent year-over-year, while sales of previously owned homes increased 0.6 percent in April from a month earlier and 9.7 percent from April 2012. The bond market, as measured by the Barclays Capital Government/Credit Index, declined 1.9 percent in May and is down 0.9 percent since Jan. 1.

GDP in the eurozone fell at an annualized rate of 0.9 percent during the first quarter — the sixth straight quarter of a recession — and the region's unemployment hit a record high of 12.2 percent in April, up from 12.1 percent in March. The European Central Bank cut its lending rate for commercial banks in an effort to stimulate the eurozone economy. Japan's GDP grew at an annualized rate of 3.5 percent in the first quarter, up from the 1 percent growth rate at the end of 2012. International equities, as measured by the MSCI EAFE, decreased 2.3 percent during May and were up 8.3 percent May year-to-date.

HARNESS THE POWER OF THE PORTAL

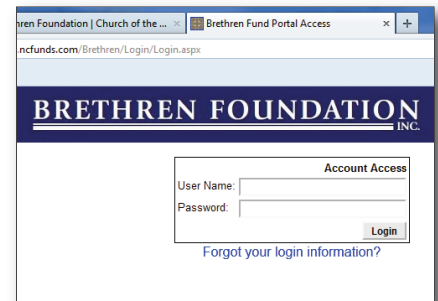
As of the end of May, more than 45 percent of Brethren Foundation's organizational clients have authorized individuals to use the BFI client portal. Those who use the client portal have the earliest access to statements and the latest issue of *Investment Perspective* each month. All online users also have access to past statements; an electronic copy of the most recent edition of BFI's disclosure document, the *Information Statement*; and past issues of *Investment Perspective* (which are also available at www.bbtfoundation.org).

But there are account management features beyond accessing current and past reports and documents. Users of the client portal with full access may initiate transactions electronically and generate a variety of custom reports in addition to receiving regular monthly statements. Users with full "look-only" access may generate custom reports in addition to receiving regular monthly statements. Statements and performance reports can be prepared for custom date ranges. Account activity can be reviewed at both the summary and detail level for custom date ranges. Reports can be exported for use either as spreadsheets or PDF documents. Online users can receive assistance via the help section of the client portal or submit specific requests via the request feature within the help section.

All users of the client portal receive monthly statements, the annual *Information Statement*, and monthly issues of *Investment Perspective* only in electronic format via the client portal, thereby enabling BFI to reduce paper consumption.
